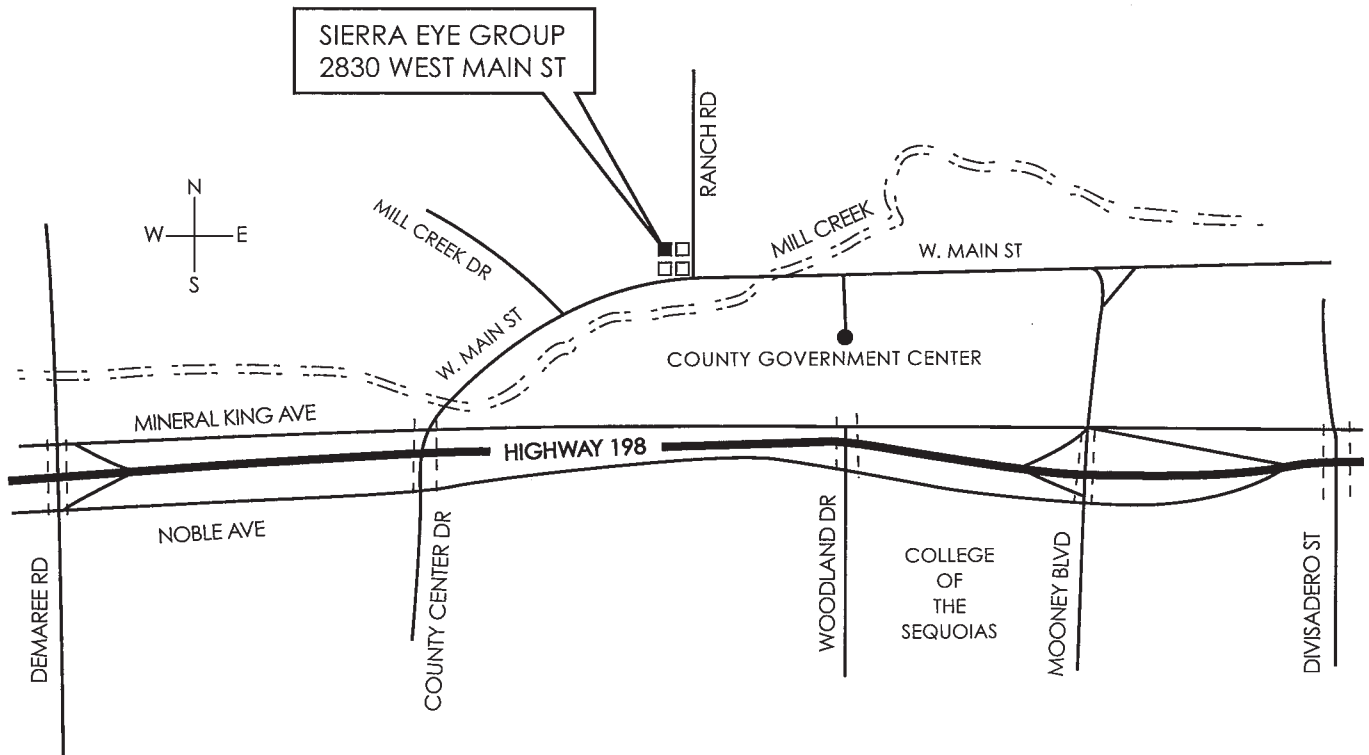

# DIRECTIONS TO SIERRA EYE GROUP

Sierra Eye Group is easily accessible from the four county areas it serves. Tulare County residents, familiar with Visalia, can easily find the clinic using the map above. Our address is 2830 West Main Street, Visalia.

Kings County visitors should take Highway 198 east toward Visalia, while patients in Fresno and Kern Counties should take Highway 99 toward Visalia and turn east onto Highway 198.

East bound visitors on Highway 198 should take the Demaree Road exit the merge onto east bound Noble Avenue, traveling 4/10 of a mile east to turn left onto County Center Drive which crosses over Highway 198 and immediately changes to Main Street. Travel 3/10 of a mile and then turn left off Main Street into the office complex of tan buildings.

West bound visitors should leave Highway 198 on the Mooney Boulevard exit. You will then travel 1/10 of a mile on Mineral King Avenue before reaching Mooney Boulevard. Turn right onto Mooney Boulevard and travel 1/10 of a mile north to Main Street. Turn left on Main Street and proceed one-half mile west to Sierra Eye Group, which will be a right hand turn into the office complex of tan buildings.
